NEWS OF THE NINTH ANNUAL REUNION AND MEETING 12-14 AUGUST 1983

The Board of Directors (B)D) met at the American Legion Post 166, Goose Creek, on Saturday morning, 13 August 1983. The meeting was called to order at 0925 by President Lyal Stryker and attending were John Lemieux, Vice President and BOD members Toby Horn (who acted as Secretary), Bob Forbes, Jack Smoot, Phil Dechene, Charlie Hunt and Dick Schommer, Chairman of the Mine Museum Committee. Ron Swart, our Secretary was transferred to Sigonella so Lyal Stryker made the Secretary/ Treasurer report as follows:

- Membership a total of 776 plus 6 honoraryand of the 776, there were 614 regular and 162 associates.
- Treasurer Report checking account balance of \$4,081.91 and savings account balance of \$478.64 before the bills were paid. Our post reunion balance was \$577.77

The following reports were also made:

- <u>Dinner/Picnic</u> Bob Forbes reported that all arrangements were completed; cocktails would be from 1830 to 1930, dinner served around 1930-2000 and open bar until 2330 with music by a disc jockey. The picnic will be at the Navy recreation area at Short Stay and in addition to the usual beer/hot dogs/hamburgers, there would be fresh crabs.
- Mine Museum Dick Schommer reported that work was progressing well and they could use help on Saturdays. The display area is about 75% complete and would be opened to the public in the fall as one of the USS YORKTOWN tour routes. A helmholtz coil/test set has been located at Yorktown and will be shipped to us in the near future.
- <u>Historical</u> Lyal Stryker reported that we continue to receive documents and some will be on display when the Mine Museum is opened. All of our records and other historical documents have been stored in fire proof safes on board the USS YORKTOWN in our work/office spaces. The Keyport Undersea Warfare Museum has indicated they would appreciate our advice when they are ready to select mine material for display.

- Constitution and By-Laws Phil Dechene presented a proposed change to allow for the forming of chapters. The proposed change was approved at the previous year's meeting (1982) in Yorktown and at this year's meeting the BOD approved the wording of the proposed amendment and recommended the membership approve the amendment.
- <u>Mailing List</u> Lyal Stryker reported that we hope to have the mailing list available by the fall or early spring. It is planned to have the list transferred to the local office where Lyal works to be put on their computer which will facilitate updating and can be made available as needed. At present we have to pay a local company for this service.
- Honorary Mineman Captain R. J. Fromholtz, U.S. Navy, Commanding Officer of the Fleet and Mine Warfare Training Center was recommended for the award based on his career in the Navy, much of which was in Mine Warfare and especially his recent contribution to raising the esprit-de-corp of the Mineman rating through his vigorous personal leadership at the school.
- Consolidated Order of Clock Cockers (COCC) Award MNCM Milt Baird is the only qualified recipient this year.
- Charter Membership Plaque This was suggested by MNCM Billy Owers some time ago. Toby Horn and his membership committee have looked into the matter and talked to a lot of people about the idea. The general consensus seems to be that it would be virtually impossible to define a criteria that would be acceptable and in view of our early records which are missing some dates as to when individual members joined, the BOD recommended the suggestion to create a Charter Membership Plaque not be pursued.
- <u>Lifetime Membership Dues</u> Several members have suggested that in lieu of an annual mailing/administrative fee of \$1.00 we go to a lifetime membership fee. Toby Horn and the membership committee are looking into the suggestion and investigating what other comparable organizations charge, etc. Toby hopes to have a recommendation to submit to the BOD before the 1984 meeting.
- TENTH Annual Reunion/Meeting Reno had been suggested as a possible location during the meeting last year (1982) and the subsequent newsletter asked for the members to comment on where they would like to meet in 1984 for our Tenth Reunion. We received less than ten (10) written responses which agreed with Reno and in addition few verbal comments during the year that were favorable. Dick Schommer checked with a couple of travel agencies and found that to charter a plane would be too expensive and that even a special individual fare and travel package would range from \$380.00 to \$650.00 per person, depending on arrangements. The BOD, after considerable discussion, recommended the matter be brought up at the general membership meeting for discussion and resolution.
- Nominating Committee The following slate of officers were recommended; President Dick Schommer; Vice President John (Frenchy) Lemieux; Board of Directors Homer Reagan and Carily Wallick. In order to stabilize turnover of the Board of Directors every year and accommodate the addition of a sixth member of the BOD, it was proposed that we elect two new BOD this year for a three year term, Toby Horn and Jack Smoot continue for one more year through 1984 and Phil Dechene and Bob Forbes continue for two years through 1985. Charlie Hunt requested to be relieved due to his work schedule that prevented him from participating more actively. The BOD accepted the recommendations of the nominating committee and voted to submit the list at the general membership meeting. It was noted that nominations would be encouraged and accepted from the floor during the general membership meeting.
- <u>Installation of Officers</u> Lyal Stryker presented a proposed procedure that was accepted. RADM Horne would perform the installation ceremony and Phil Dechene would act as Chaplain.

There was no other business to come before the Board of Directors and the meeting adjourned at 1145.

GENERAL MEMBERSHIP MEETING

The general membership meeting was held at the American Legion Post 166, Goose Creek on Saturday, 13 August 1983 commencing at 1325. The following business took place:

- 1. Minutes of the Boardof Directors were read and approved by the voting members present.
 - 2. No old business was presented.
 - 3. Under New Business:
- a. The amendment to the C&BL's to allow for the forming of Chapters was read by Phil Dechene. After some discussion the amendment was approved. The amendment is printed at the end of this section.
- b. Tenth Annual Meeting and Reunion. The idea of going to Reno or elsewhere in the same vicinity was discussed. A motion was made to go back to Yorktown. The motion was not carried. The matter was then discussed again with the general consensus being that we were unable to agree on a suitable arrangement for Reno or anywhere else other than Charleston or Yorktown at this time. A motion was made again to hold the next meeting in Yorktown and the motion carried unanimously. It was noted that Yorktown is the location of the Navy's only Mine Depot and Naval Schools Mine Warfare years back and our Tenth Reunion and Meeting there is most appropriate. Jack Smoot volunteered to head the Reunion Committee.
- c. The slate of officers submitted by the Nominating Committee and endorsed by the BOD were read to the memership and approved. The floor was opened for nominations for President in addition to Dick Schommer. No other nominations were made and a motion was made to close the nominations, dispense with ballots and elect Dick Schommer by acclamation, Motion carried. The floor was then opened for nominations for Vice President in addition to John Lemieux. No other nominations were made and a motion was made to close the nominations, dispense with ballots and elect John "Frenchy" Lemieux by acclamation. Motion carried. floor was then opened for nominations to the BOD in addition to Homer Reagan and Carily Wallick. Dan Epperly, John Mussig and Dale Steinhoefel were also nominated for the two BOD positions. Nominations were closed and ballots issued to vote for two new members of the BOD to serve three years. Dan Epperly and Carily Wallick were elected. The officers for the Association of Minemen are as follows: President, Dick Schommer; Vice President, John "Frenchy" Lemieux, BOD Dan Epperly and Carily Wallick for three years; Phil Dechene and Bob Forbes for two years; Toby Horn and Jack Smoot for one year.
- d. The floor was opened for any other new or unfinished business. The amendment to the C&BL's were generally discussed and following the discussion it was resolved the amendment was adequate for the purpose it was designed for.
- e. Fred Reid brought up the matter of holding the Early Board and membership meetings at a location where there would be no distractions and members could converse and meet within our own group. Following the discussion, it was agreed that the Tenth Reunion Committee would attempt to arrange for suitable meeting facilities.
- f. There was no other business to be brought before the membership and the meeting was adjourned.

Greetings. Lyal Stryker welcomed everyone to the Ninth Annual dinner meeting and thanked them for attending. The head table was introduced, which consisted of RADM and Mrs. Horne, Captain and Mrs. Fromholtz, Dick and Sue Schommer, Lyal and Doreen Stryker and John "Frenchy" and Edna Lemieux. Also recognized as distinguished guests with us were Captain Riley, COMOMAG, LT J. B. Orr, Officer in Charge, MOMAG DET ELEVEN and CWO4 Jack Smoot and members of the MOMAG Reserve

Guest Speaker. Captain R. J. Fromholtz, U.S. Navy, Commanding Officer of the Fleet and Mine Warfare Training Center was our guest of honor and speaker and was introduced by Phil Dechene. A committee composed of Phil Dechene, Bob Forbes and John Lawton prepared a proposed amendment to the C&BL's concerning Chapters. The following proposal was submitted to the Board of Directors which approved them for submission to the membership for approval: Art V Sec 1 Add: and Chapter Chairmen as required by Article X Section 6. Sec 3 Chng: Five members to six members and delete "beginning in 1979 after initial appointment."

Article X: Chapters

Section 1 The right to organize an Association of Minemen Chapter may be granted upon petition of ten or more enrolled voting members as, described in Article IV, Section 1, all of whom are from one of the geographic areas listed in Section 10. The petition shall designate one of the signers as temporary Chairman in Charge of the organizational activities. It shall be directed to the Board of Directors and addressed to the Secretary. It shall be inherent to any petition that the proposed chapter will conduct themselves according to the National Association of Minemen Constitution and By-laws.

<u>Section 2</u> The temporary Chairman shall be notified upon approval of the petition by the Board of Directors. A list of all members in his region shall be forwarded and he shall notify each member of a date for an organizational meeting, at least

30 days prior to the scheduled meeting.

Section 3 Chapters will be numbered in the order the petitions are received and may be named for the geographical area in which located, as requested in the

original petition.

Section 4 Nothing herein shall prevent an individual from becoming a member of the Association of Minemen without joining the regional organization wherein he lives. A member can belong to only one Regional Chapter. Transfers between Regional Chapters may be made in the interest of accommodating the members proximity to newly established chapters within a region.

Section 5 If Chapter membership falls below 10 voting members then the Chapter

shall be disestablished.

Section 6 Each Chapter Chairman shall be a voting member of the National Board

of Directors for matters of chapter interests.

Section 7 The Board of Directors shall be the authority on all matters relating to amendments of boundaries or additions to or consolidation of any region established under this article.

Section 8 Rulings by the Board of Directors may be appealed at the General

Membership Meeting.

Section 9 Any chapter operating in a manner to bring discredit to the Association of Minemen shall be subject to expulsion from the organization.

Section 10 The geographical regions shall be established as follows:

Northeast: Maine, Rhode Island, New Jersey, New Hampshire, Connecticut, Delaware, Vermont, New York, Pennsylvania, and Massachusetts.




