## William & Emma Mehard (Charleston, SC)







# LEANING ON THE TAFFRAIL



## **MAAG DUTY IN TAIWAN**

I was assigned to the Military Assistance Advisory Group (MAAG) - Taiwan, 1967 to 1969. Being a Mine Warfare (MIW) advisor for the Republic of China Navy (ROCN), at Tsoying Naval Base, was a highlight of my navy career. Tsoying is located in the south, near Kaohshiung.

During my first weeks on the naval base, I spotted several USN exercise mine recovery floats by the side of the road. The floats were from a MINEX the year before. Their nylon recovery lines had been removed, but several had unfired explosive fittings installed. I took the floats back to head-quarters and removed the explosives without incident. The ROCN did not have EOD personnel. They relied on UDT divers to supplement their meager MIW force.

Early on, I visited Makung, on the Penghu Islands, and was disappointed with the state of the many weapons stored there. I convinced the Navy brass they should conduct a Fleet Service Mine Test, similar to that used by the USN. During the operation some of their moored contact mines didn't work properly. The chemical horns and detonators checked out, but the electrical wiring was faulty. Corrosion on an electrical contact point made of brass kept the mines from firing. A few strokes with emery cloth and the old mines worked okay.

When a mainland Chinese ship conducted suspicious operations at night near the island of Kinmen, two coastal minesweepers were sent out to check for mines. When we arrived off Kinmen, the tension was high and the guns were manned as we conducted mechanical sweeping where the Chinese ship had operated. Nothing popped to the surface. Then an acoustic device was used with no results. The sonar operator didn't see any mines either, so we returned to Tsoying. We had been tricked into an expensive sweep operation.

Every year, P3's from Okinawa would drop exercise mines close to Tsoying. Due to strong currents and bad luck we were never able to recover all of the mines. One year, the sweepers managed to cut-off most of the recovery floats and they popped to the surface. It was very embarrassing to all concerned.

By early 1969, U. S. foreign policy had changed and up to 50 advisors a month were leaving. When the Amphibious and Gunnery advisors departed, I assumed their duties, too. In rapid succession I participated in an amphibious landing south of Kaohshiung, a refueling at sea with a USN ship, and an anti-aircraft gunnery exercise.

In May, 1969, I was sent TDY to the Army base at Long Binh, South Vietnam. By then I was an MNČ, and I relieved an Army E-8. My boss was an Air Force major, and his boss was an Army colonel. Our job was to help Taiwan acquire excess U.S. Army equipment at the Property Disposal Depot. When the new M115 jeeps arrived they turned in their old M38s, which were still in very good condition. Monthly, ROCN LST's delivered loads of bagged cement to the Newport Terminal, and soon as they were empty we backloaded them with jeeps, trailers, and trucks of various sizes. In mid-July, 1969, the AF-major and I flew up to Danang for a few days, where we were given a mysterious wooden box to handcarry back to Taiwan. We suspected the box contained captured AK-47's, but we didn't know for sure.

All things considered, the MAAG duty was a bittersweet learning experience. I went there unaware of the tension/hostility between the exmainland Chinese and the native-born Taiwanese. For example, one day we learned a Taiwanese civilian had been executed for stealing gasoline at a military base. It was frustrating and counterproductive to work in an environment like that, but, I was satisfied with my performance and I looked forward to my next assignment.

INGLESIDE, TEXAS – What's that old saying — if you can dream it; you can do it? Two boys growing up in Newark, N.J., during the late sixties and seventies are proof positive it's more than just an old saying.

One of the brothers' favorite games was pretending they were Sailors on a fantastic adventure on the high seas. Pillows on the floor represented the deep oceans; their beds represented the great tall ships of some impressive imaginary fleet. Fearlessly, they would encounter and prevail over anything in their bedroom from turbulent ocean waves to giant sea monsters to menacing pirates.

Today, those young "sailors" are serving as officers and gentlemen of the U.S. Navy — and as fate would have it, both are stationed in Ingleside, at the "Mine Warfare Center of Excellence." They're the Wyatt Brothers, and this is their tale.

The Brothers LCDR Julian Wyatt is the commanding officer of Mobile Mine Assembly Unit 15. He assumed command in October 2003.

The 44-year-old bachelor holds a bachelor's degree in liberal arts from Regents University (now Excelsior College); a Master's in Education from Old Dominion University in Norfolk, and is currently working on an MBA in Human Resources from Florida Metropolitan University.

Four years younger, LCDR Jason Wyatt is the READRON Operations Officer for MCM Squadron Two and has been

there since March 2003. He holds a bachelor of arts degree from Dartmouth College, in Hanover, N.H.

The Formative Years

Growing up in Newark, Julian and Jason saw little of their dad, Archie, during a typical workweek. "Dad would leave for work around six in the morning, and we wouldn't see him again until much later that night," Julian said.

Every day, he took an hour-and-a-half bus ride from Newark to New York City, then boarded a train for work in Manhattan, where he worked for the New York Times and at a clothing distributing company.

Little wonder Julian and Jason were so close growing up, and enjoyed participating in many activities together such as martial arts and running.

Archie, now deceased, served as a medic in Vietnam. Their mother, Anne, now lives in Whiting N.J. The Wyatt brothers have one married sister, Natasha. Another sister, Tanya, is a retired first class cryptologic technical (communications).

Answering the Call

Julian entered the Navy in June 1980. He said he got the taste for the sea service shortly after high school, when he worked with the merchant marines during a 42-day stint over the summer to earn money for college.

"I absolutely loved it — it was my first time working at sea," he said. But after a year at Worcester State College, he realized he wanted to pursue a career in the Navy. And it wasn't all motivated by love of the sea.

"There's a strong notion of honor in our family, so joining the Navy also gave me a chance to do something for my country," Julian said.

Julian's recruiter told him which schools he qualified for, but warned him that once he got into a rate he would be more or less "stuck with that rating for the rest of his life."

That notion didn't appeal to Julian.

"I opted to go in as an undesignated seaman. The recruiter told me that by doing that, I could at least figure out what I liked and what I didn't like."

One thing the young Sailor found out was that he didn't like chipping paint all day — that revelation coming after a couple of months aboard USS Sterett (CG 31). Julian applied for the Limited Duty Officer and Chief Warrant Officer program, and was subsequently picked up the first time and commissioned an ensign in 1994, while serving aboard USS San Bernardino (LST 1189).

One of Julian's earliest memories as an officer was serving in the precommissioning crew for USS Gonzalez (DDG 66), as the ship's systems test officer (STO).

"Precomm crews are very tight," he said. Julian added that what made it so enjoyable was having what he called a major input in how the ship was designed.

Julian left the ship in 1998 as a lieutenant, and headed to Dahlgren, Va., for PCO/PXO instructor duty for the Aegis Weapon System.

In 2002, Julian found himself in Bahrain as Fifth Fleet ordnance officer with Combined Task Force 53 under COMUSNAVCENT.

In addition to serving aboard Sterett San Bernardino, and Gonzalez, Julian served aboard USS Reeves (CG-24).

On the other hand, Jason's "real" Navy adventure began in 1990, while brother Julian, then a chief gunner's mate, was a weapons technicians instructor at Nuclear weapons training group, Pacific in San Diego. Jason had marked time for four years after high school, trying his hand at a

variety of jobs. "I'd worked in a mental hospital, sold securities, worked as a security guard — and with a newspaper," he said. "But nothing really stuck with me."

He said he finally decided to join the Navy as Desert Storm was brewing, partly because of the postcards he'd gotten from Julian and his sister Tanya from overseas and CO-NUS duty stations. "Both Julian and my sister made the Navy sound like a great place to be.

"It also gave me a chance for me to figure out what types of skills I'd be best at using, as well as giving me a chance to serve my country."

Jason earned his Naval commission in 1990 through Officer Candidate School, Newport, R.I. After completion of Surface Warfare Officer school in San Diego, he reported aboard USS Mount Vernon (LSD 39), as second division officer, Deck Department. Jason served aboard Mount Vernon through 1994, also seeing duty as ship's CIC

With the drawdown of forces following the Persian Gulf War, Jason accepted commission as a Reserve officer, and was given the opportunity to become a TAR (training and administration of reserves).

"I accepted the conversion, Jason said, "and got orders for Omaha, Neb., as executive officer of the Navy and Marine Corps Reserve Center."

Obviously, Jason didn't see any ships in Nebraska, but it was during that stint he actually saw someone working in rates he had only read about in the Bluejackets Manual – steelworker and lithographer.

His next assignment was a little closer to water — Department Head School in Newport, R.I.

His following assignments got him much closer to water Đ as operations officer aboard USS Lewis B. Puller (FFG 23), from 1996 to 1998; and later aboard USS Ogden (LPD 5), from 1998 to 2001.

Following consecutive sea assignments, Jason reported for duty as commanding officer at the Naval Reserve Center, Glens Falls, N.Y., where he eventually put on lieutenant commander bars.

Rendezvous at NAVSTA
"I asked for South Texas," Julian said. "One of my goals when I originally came in the Navy was to make master chief as soon as I could — because they never have to stand duty.'

He added that one of his ultimate goals in the Navy was to be a commanding officer, be it aboard ship or at a shore station.

He got some good information from his detailer. "I learned that for LDOs, the only place you can become a commanding officer — as opposed to an officer-in-chargein the mine warfare community. When I heard that I knew it was for me.

He lined up his follow-on assignment before he went to Bahrain. Julian said that commanding MOMAU 15 "is like a dream come true.'

"It's a lot of hard work, but it feels fantastic," he added, "but it has far exceeded any of my expectations.

Julian attributes his success to leadership by example, continuously trying to quality for the job you are in (prevents stagnation) and his 4E-1P Formula: positive Energy; ability to Energize others; Edge — the courage to make tough yes-or-no decisions; the ability to Execute-in order to get the job done; and Passion. You have to be passionate about work, about life, about everything! It is contagious. Additionally, he likes to "empower people."

His goals for everyone under his command is that they have or get started working on their associate degrees.

After completing his going from at-sea department head billets co command ashore, forty-year-old Jason told the detailer he was ready to get back in touch with the fleet when it was time for him to leave the Reserve Center at Glens Falls.

"I am very easy going and was ready to go wherever the detailer needed me to be. We looked at Norfolk, but the timing wasn't going to work. Then my detailer offered me the Squadron operations officer job — and here I am. The CO's and crews on these ships are some of the hardest working Sailors in the Navy. It wasn't part of my plan, but I have really enjoyed being in Texas, and it's nice to come back to warm weather."

Although the brothers work on the same base, they have opposite jobs within the mine warfare community.

Julian's mission is to prepare mines to be placed in the water for exercises and operations; while Jason works with ships that are trained to hunt, sweep and neutralize sea mines.

The rest of the story

Julian enjoys martial arts and running, when not engaged in educational pursuits.

Jason likes to spend time with his family, computers, and bicycling — in that order.

He and his wife, Rosa, live in Portland with their three children, but they will be leaving South Texas later this summer, when Jason reports for duty with OPNAV staff in the Pentagon.

Julian will continue his Naval career as CO of MOMAU 15 until some time next year. He is currently negotiating with detailer for his follow-on assignment.

More than a job

The one word that sums up Julian's Naval journey is, as he puts it, "Rewarding – there's no better word for it. I feel blessed," he said. His motto has always been "Invenium Viam Aut Faciam'; I shall find a way or make one.

His achievements affirm that motto. He's earned two Navy and Marine Corps Commendation Medals, three Navy and Marine Corps Achievement Medals, a Navy Unit Commendation, a Meritorious Unit Commendation, a Navy OEO Ribbon, five Good Conduct Medals, two Navy Expeditionary Medals, two National Defense Service Medals, an Armed Forces Expeditionary Medal, the Clobal Wor on Toronian Expeditionary Medal. Medal, the Global War on Terrorism Expeditionary Medal the Global War on Terrorism Service Medal, the Korean Defense Service Medal, two Humanitarian Service Medals, five Sea Service Deployment Ribbons, the Navy and Marine Corps Overseas Service Ribbon, the Republic of Korea Presidential Unit Citation, a NATO Medal, the Expert Pistol Shot Medal, and the Expert Rifleman Medal.

Jason said the one word that would sum up his Naval experience is "diverse."

He's proof positive of that notion. He likes to think of himself as "your average lvy-league guy who is OCS, with experience in amphibs, cruiser/ destroyers and mine warfare who happens to be a TAR.'

His advice for junior Sailors? "Be ready to commit yourself and give your all," he said. "You don't gain anything by just going 'along for the ride.' You got to push yourself - be involved."


ment requests and war-fighter support, and you can imagine the number of work orders processed. A hearty "BZ" goes out to all departments for work order processing!

# 4 MIW SHIPS DEPLOY TO SUPPORT HURRICANE KATRINA RECOVERY, RELIEF EFFORTS

NAVAL STATION INGLESIDE, TEXAS — Four mine warfare ships deployed this afternoon, beginning at 3 p.m., to support Hurricane Katrina disaster recovery and relief efforts. USS GLADI-ATOR (MCM 11), USS SCOUT (MCM 8), USS CORMORANT (MHC 57) and USS DEFENDER (MCM 2) will work with the U.S. Coast Guard. U.S. Army Corps of Engineers, and National Oceanic and Atmospheric Administration to clear waterways that may be clogged by debris. The ships will use Unmanned Underwater Vehicles and their divers to locate and identify items that could cause unsafe passage and inhibit recovery and relief efforts in the affected areas. The mine warfare ships are under the tactical command of Cmdr. Jon Lux, Chief of Staff, Mine Countermeasures Squadron Three. The ships are homeported at Naval Station Ingleside, Texas.
